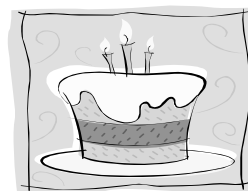

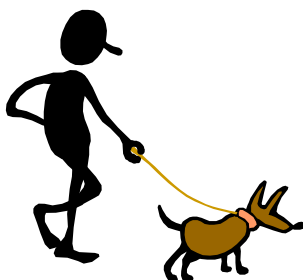

Training Director's Report

November 2009

We are in the final session of classes for 2009!

There have been some changes and additions to the schedule this session which we hope will provide new opportunities for our members and students:

1. Ann Hopp is offering a Foundation course for the Agility program, which will help to prepare dogs/handlers for further work in agility.
2. Roger Fremo will be adding Grad Novice work in the Wednesday Novice Obedience class. Since we are hoping to add Grad Novice at our July Trials this will give our students a chance to prepare for that level of competition.
3. Pre-Novice exercises will be introduced in the Advanced Beginner's class on Wednesday. The Canine Good Citizen curriculum will still be emphasized in that class.
4. Due to lack of enrollment, the Saturday Puppy Kindergarten class will not be offered this session. Students are encouraged to join the Thursday class at 6:30.
5. Punch cards are now available for those who can only attend classes occasionally. Contact Denise or Lavonne for information about the cards.
6. There will be no classes on Thanksgiving Day—November 26th. Check with your instructors about Saturday classes that weekend.
7. In case of severe weather, please contact your instructor or Lavonne Marubbio to be sure your class will be held as scheduled. Notices of cancellations will be posted on local radio and TV stations.

We are privileged to have Audrey Peterson conduct a session of "Private Lessons" for those who are preparing to show their dogs in Obedience. This workshop will be held at the Training Center on Friday, November 13th. This is a great opportunity to get ready for the FMKC Obedience Trials on Nov. 14 & 15.
