

Board Meeting



January 19, 2009

Attendees: Nancy Lindblom, Mary Higdem, Kathy Lehman, Kris McDonald, Lavonne Marubbio.

The meeting was called to order at 7PM by Acting Vice President Kris McDonald in the absence of President Brian Vail.

Kathy gave an IRS report. The Club's 2007 tax return was filed 6 months late. The deadline was May 15 for non profit groups. Kathy has written a letter to the IRS to waive a possible \$1600 penalty. The Club status is 501 C4 for tax purposes.

Kris reported on the Dog Directory for Ian McDonald. State sales tax in the amount of \$114.72 has been paid. After expenses the Club will make a profit of ~\$500. A Directory checking account at State Bank & Trust of Fargo will be kept open until all checks clear. Kathy requested that the account be kept open with the intent of moving the Club account from Northwestern State Bank in Dilworth to Fargo for convenience sake. Ian's report will be kept with Kathy's tax information.

The obedience & rally trials were discussed. Kris reported that an error in scheduling has been corrected and that the new judging schedules have been approved. Jumps and ring gating were discussed. Mary suggested the purchase a full set of regulation jumps (high, bar & broad) from Acme for an estimated cost of \$390. Nancy thought that one set of wheels for an additional \$35 would be a good idea. A motion to buy the jumps plus wheels was made by Mary and 2nd by Nancy. Motion carried. Mary also suggested approaching the Clay County 4H Club about renting/buying their ring gating before buying a set. She will call Carol Erickson. Lavonne proposed serving cake in celebration of the 10th Anniversary of the Club on Saturday during the Trials.

A motion to adjourn was made by Mary and 2nd by Nancy. Meeting adjourned at 8:00 PM.
