Meeting called to order at 8:15PM by President Brian Vail.

President's Report: In "Paw Prints".

<u>Secretary's Report:</u> A motion to approve minutes of the last meeting as published in "Paw Prints" was made by Janine and 2nd by Dave. Motion carried.

<u>Treasurer's Report:</u> No report in Paw Prints. There will be a financial report for 2 months in the next issue.

<u>Training Director:</u> Classes were suspended for 2 weeks due to weather & the flood. Current session extended by 2 weeks (ends May 9). The next session will run from May 11 to July 2.
