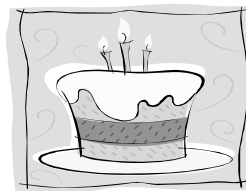

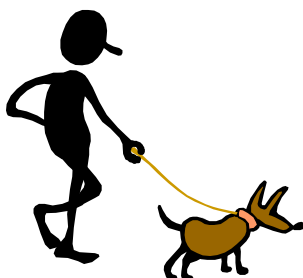

Meeting called to order at 8:15PM by Kathy Lehman, filling in for Brian Vail.

**President's Report:** In "Paw Prints".

**Secretary's Report:** A motion to approve minutes of the last meeting as published in "Paw Prints" was made by Sandy Sutter and 2nd by Mary Brinkman. Motion carried.

**Treasurer's Report:** Report published in the most recent "Paw Prints". A motion to approve the report was made by Patti and 2nd by Sandy . Motion carried.

**Training Director Report:** Denise Luther reported that she will be filling in as Training Director while Lavonne takes a leave of absence. Class sizes are good for the current session.

**Trial Committee Report:** Kris indicated that the AKC had the wrong schedule published in the AKC Gazette but it was correct on the website. It was mentioned that attendance has been lower at other recent trial events. Possibly, with our 3 day event, it will draw more entries. We are still in need of steward volunteers. There is a signup and there will be steward training prior to the trial.

**Unfinished Business:** Kathy discussed the painting of the training center. She had Colors by Kari come in and recommend a color scheme along with providing a quote for painting (yet to be received). Building owner is willing to pay for painting supplies as long as RRNDOC pays for or provides the labor. Prior to painting occurring, some clean-up of the building would occur. Members are asked to mark items you own and want, otherwise items may be discarded or moved. During discussion about painting, a suggestion was also made to install ceiling fans. It was agreed that this was a good idea and that price and feasibility should be looked into.

**New Business:** Kathy reminded members that the Rummage Sale will be the weekend after the trial. She bought tables that can be used for the sale.

Kathy mentioned that she received the OK from the building owner to have a post installed by the front door which we could use for attaching a poop-bag dispenser, just like local parks are using.

Kathy mentioned that club is looking into other, less costly, options for storage of the extra mats. Currently, we are paying \$150 per month in rent.

A motion to adjourn was made by Dave Arnholt and 2nd by Mary Brinkman. Meeting adjourned at 9 PM.
