Our club was also well represented, as always, at the recent Agility trial, and April is starting off with an Obedience/Rally trial, so good luck to all entrants!


We have been very fortunate to have such high-quality activities at our club, and I urge you to provide your input for any additional functions that we could hold.

# Training Director's Report April 2010



Happy Springtime to Everyone!

It is good to be able to get our dogs outdoors once again after the long winter. The Fargo-Moorhead community has been very fortunate to have escaped major damage from this year's flood. We did not have to cancel any classes because of the flood!

Our class enrollment for this session has been very good. It is gratifying to see the progress that the dogs and handlers make during the 7-week sessions. We held a Canine Good Citizen test on February 28<sup>th</sup>. We hosted a Sunday training date with Audrey Peterson on March 7<sup>th</sup>.

We are looking forward to our next session, **Session III (Spring) April 12 – May 27<sup>th</sup>**, which begins in just a few days. [See attached Schedule] You will notice some changes in the classes this time:

- **1. Ann Hopp's Foundation Class** will not be offered during the spring and summer months.
- 2. Beginning Agility will move to Tuesday evenings at 6 PM.
- 3. Advanced and Competitive Agility classes will be combined, and will meet from 7:00 to 8:30 on Tuesday evenings.
- **4.** There will be **no classes on Memorial Day weekend**. The class fees have been adjusted for the Saturday classes.
- 5. Rally Drop-in will be held on Friday evenings from 6:30 to 8:00 PM. Brian and Vicki Vail will coordinate that event. The cost is \$5 per time/per dog. Please contact Brian at <u>bvail@q.com</u> or (218) 483-4322 for more information.
- 6. We plan to host a Rally Open House in May. Time and dates will be announced.

We are looking ahead to the **Obedience and Rally trials on July 23, 24 and 25, 2010.** Now is a good time to start practicing with your dog in preparation for the trials.

We are also making plans for some special training opportunities in the summer. We will let you know more about them as soon as possible.


