

Our enrollment has been excellent for both sessions, with the large Puppy Kindergarten, Jump Start Obedience and Beginning Obedience classes at full capacity. The other obedience classes, agility and rally classes are also well attended. I want to thank all the instructors and students who have braved the elements to bring their dogs to school.

#### **Emergency Preparations**

Now a good time for all of us to review our plans for ourselves and for our pets.

- I. Have an evacuation plan in the event that you must leave your home.
- 2. Make sure that your pets have collars and ID tags, and/or are Micro-chipped.
- 3. Gather all the necessary registration and veterinarians' records for all your animals.
  - 4. Have a photo of each pet, together with his/her information.
- 5. Prepare an emergency (3-7 day) supply of your pets' food and medicines to take with you.
- 6. Have portable crates ready, in case your pets must go to a shelter.
- 7. Prepare a list of contacts in case you are separated from your pets.
- 8. Notify family or friends if you are forced to evacuate. Let them know where you can be reached.

### In Case of an Emergency

Who would take care of your dog if you were hurt and unable to do so? To make sure vital information regarding your dog is easily accessible to others, take a few moments to fill out this emergency information sheet.

List two or three people as contacts in case of emergency. Include the contact's name, address, and telephone number. Make sure at least one of the contacts has a set of your house keys.

You may also want your attorney to draft a written statement, which gives immediate custody of your dog to a designated individual with that individual's consent. Notify that individual of his or her responsibility, and put his or her name, address, and phone number on your emergency information sheet.

Attach a recent photo of your dog to the information sheet to help others locate your dog if it should wander off.

Put the information sheet on your refrigerator or other prominent spot in your house. You may also want to keep similar information in your wallet. If you are unable to care for your dog due to an accident or emergency, someone will be able to follow the instructions on the sheet to provide necessary care.

Meeting called to order at 8:15 PM by President Denise Luther.

President's Report: In "Paw Prints".

<u>Secretary's Report:</u> A motion to approve minutes of the last meeting as published in "Paw Prints" was made by Mary and 2nd by Vicki. Motion carried.

Treasurer's Report: Report will be in the next Paw Prints.

Report of the Trial Committee: Brian reported that Dave Arnholt will serve as Chief Obedience Steward and Mary Brinkman will be the Chief Rally Steward. Two judges are from Canada and a provisional judge from Minnesota. The premium is due in May so all prizes will have to be determined by then. A group will get together to make tug toys again. The Board approved the purchase of trial software. Dog Shows by Design (DSBD) will charge \$1700 this year. With this new software we should be able to serve as our own superintendent. Brenda McBain will serve as secretary this year. We will hire DSBD but run the new program as well to check it out. Funds set aside previously will be used for this purchase. There will be a signup sheet for stewards.

<u>Training Director:</u> Lavonne reported that there is good enrollment for this session. Flooding could be a problem again this year. Classes will be cancelled if necessary. A rebate or discount would be offered to make up for any missed class. The agility equipment has been cataloged.

<u>Unfinished Business:</u> Denise is looking for someone to take over publishing "Paw Prints" for the summer. Brian Vail will train.

New Business: There was a first reading for Paul McNutt (Golden Retrievers).

The Club patches are in. They are available from Cyndy for \$6. Also, Herbergers coupon books are available. Dogs are needed for Saturday's sale. It has been a good money maker for the Club in the past.

# **Board Meeting February 21, 2011**

Meeting called to order at 7:20 PM by President Denise Luther.

Brian discussed the upcoming obedience and rally trials. Judges are under contract. Angie R. has offered \$50 for a High In Trial Prize. Dave will serve as Chief Obedience Steward and Mary Brinkman as Chief Rally Steward. A food committee is needed. Roger will do Buildings and Grounds. New regulation jumps will be ordered. A request was made to order the trial secretary software used by the FMKC for obedience and rally trials at a cost of \$250. Agility could be added at a later date for \$200. This includes free upgrades. Dog Shows By Design will charge \$1700 this year. A motion to purchase this software was made by Mary and 2<sup>nd</sup> by Cyndy. Motion carried. Brian suggested the need for a club credit card to be used for last minute trial purchases, etc. Kathy advised against it as it would be hard to monitor.

Denise mentioned that Kathy has only 1 more year as treasurer. The club should purchase a laptop and QuickBooks to make the transition to a new treasurer more smooth. The books to be approved in April.

The agility equipment has been cataloged. It would cost between \$3000 to \$4000 to upgrade the equipment (lighter Aframe, new jumps, etc.).

Prices for building usage were discussed. The Club insurance will cover as long as a member is present. The Board decided the fee would be decided on a case by case basis. Perhaps \$50 for 4 hours and \$100 for 8 hours.

Mary brought up the need to reword and clarify the membership year (May to April of the next year). Voting privileges are based on the pervious year's membership.

Cyndy brought up the need to change the Club website so that only the officer's emails show up in the members only tab not the general public, general public will have access to the qmail account. Denise will have Patti change it.

Motion to adjourn made by Mary and 2<sup>nd</sup> by Cyndy. Meeting adjourned at 8:10PM.
