General Membership Meeting November 21, 2011

Attendees: Mary Arnholt, Dave Arnholt, Mary Brinkman, Patti Struchynski, Jamie Neary, Roger Fremo, Janine Barnstuble, Emily Ehalt, Lavonne Marubbio, Denise Luther, Nancy Lindblom and Kris McDonald.

Meeting called to order at 8:05 PM by President Denise Luther.

President's Report: In "Paw Prints".

<u>Secretary's Report:</u> A motion to approve minutes of the last meeting as published in "Paw Prints" was made by Janine and 2nd by Dave. Motion carried.

<u>Treasurer's Report:</u> There has been no revenue this past month as no class fees were collected. The Club made \$660 from selling Herbergers Community Days coupon books. More money should be coming from Herbergers once the totals are tallied. The next sale is in April.

<u>Training Director:</u> Lavonne reported that there are 10 or 11 puppies in each class and the beginners classes are good sized. Two Beginners Level II classes have been added for the dogs/handlers who are not ready for Advanced Beginners. Agility and Rally class sizes have stayed about the same. There is only 1 RRNDOC student in Ann Hopp's Agility Foundation class (she has 2 of her own students). Ann might be willing to hold a "Crate Games" seminar.

There will be a Trainers' meeting on December 3. Trainers need to let Lavonne know what works best for a meeting time before the next schedule is set. There is a need to fine tune the Beginners curriculum.

New Business: There was a first reading for Stephanie West (Aussie).

<u>Unfinished Business:</u> Brian contacted the AKC and found out that because the Club did not hold an agility trial in time we must now have another "A" Match" to become licensed again. This means that Red River must be able to run the match alone providing scribes, timers, course builders, pole setters, etc to regain licensed status. Denise has spoken with Lois Eide and the Kennel Club is willing to help as needed. We can probably rent their building and equipment and the Kennel Club will help provide the 50 to 60 required runs. Perhaps we can also get support from the Grand Forks Kennel Club. Denise will send out an email to the membership to see how much help is available for this Endeavour. Two committees will be formed: one for the agility match and another for the obedience trials. The July trials are on hold until an air-conditioned venue can be found or another date is approved by AKC. Roger suggested Nemzek Field house at MSUM.

There is a 2 week break over Christmas (December 20 – January 2). This would be a good time to take care of some general cleaning at the building. The mats needed to be vacuumed and cleaned. Also the carpets should be vacuumed and shampooed.

Class fees have not been raised for a long time. The Board voted a \$5 increase for all classes in January to be re-evaluated in April for a possible change in July. Lavonne felt the fees at the puppy level may need to be increased due to the cost involved with the "Star Puppy" program. Dave made a motion to accept the Board's decision. 2nd by Mary Brinkman. Motion carried.

Patti painted over Mary Lee's phone number on the outdoor sign and will use 5inch adhesive numbers for the club phone number. She also found 3 inch letters that can be used for the club website.

Lavonne had Johnson Pest Control check about the wasps in the building and there were too few to treat. The exterminator felt that the few that are left will not survive the winter.

There will be no General Membership meeting in December. A Nominating Committee is needed by the end of January.

Denise found out from Brian that the time period for Red River North to hold an AKC sanctioned agility trial has run out. We need to hold another "A Match" to become licensed again. 19 people from Red River are needed to hold the match. Denise will send an email to the membership to solicit help. A committee will be formed to get things started. The FM Kennel Club is willing to help us as needed.

Brian has been looking for other venues for the obedience trials or other possible cooler dates. He is willing to serve on both the obedience and agility committees.

There will be no General Membership meeting in December. Lavonne would like cleaning done during the Christmas break. Volunteers are needed. A Nominating Committee is needed by the end of January. All Board members except Mary and Patti will be going off the Board.

The used equipment sales generated \$350 to be used for new 24 inch weave poles. The Herbergers coupon sales raised \$660 so far.

Raising class fees was discussed. Income is down and there have been no seminars to generate additional income. Advertising is a big expense. We currently advertise in Dex, Yellow Book and Smart Search. Cyndy and Lavonne handle this. A motion to raise each class fee by \$5 in January to be reassessed in April for July was made by Patti. 2nd by Janine. Motion carried.

A motion to adjourn was made by Janine. 2nd by Patti. Motion carried. The meeting adjourned at7:55PM.
