General Membership Meeting

January 16, 2012

Attendees: Mary Arnholt, Dave Arnholt, Jamie Neary, Janine Barnstuble, Roger Fremo, Hollie Halverson, Brian Vail, Patti Struchynski, Lavonne Marrubio, Kathy Lehman, Mary Higdem, Denise Luther and Kris McDonald.

The meeting was called to order at 8:10 PM by President Denise Luther. The Presidents report was printed in Paw Prints.

A motion to approve the minutes as printed in Paw Prints was made by Dave and 2nd by Janine. Motion carried.

Treasurer's Report: Kathy reported that the Club received a \$300 check from Herberger's for a grand total of \$1534 from Community Days. The Club's year to date net income was \$3026. New equipment purchases totaled \$1618. We ended the year with a cash balance of \$25,192.

Training Director's Report: Lavonne reported that 60 plus dogs are enrolled in the current session – 10 each in the puppy classes, 6 to 10 in the Beginner II class. It looks like attendance is ok even without the Forum ad. CGC testing is offered 2 times a year (spring & fall). The next one is tentatively slated for March.

There was a second reading for Stephanie West (Aussie). The vote for membership was unanimous. Welcome Stephanie.

New Business: Brian asked about a rally seminar on the new signage. Mary is willing to hold one once the regulations are set in stone.

Unfinished Business: A Nomination committee is needed. Lavonne and Kathy will serve. One more member plus 2 alternates are needed. Members were asked to contact them if you are willing to serve. The treasurer and secretary positions are open. An updated membership list is needed prior to the elections. Kathy has a rough list on Quick Books.

The agility "A" Match was discussed. Brian will serve as trial secretary, LuAnn Honek as trial chairman and Stevie Mathre as judge. The Match will be held in the Commercial Building of the Red River Fairgrounds on February 25. An agreement has been made for FMKC to receive 20% of the profit and RRNDOC will get any profit from kitchen sales. Brian made a motion to charge \$5/5 to run. 2nd by Dave. Motion carried. Mixed breeds will be allowed with proper AKC registration. Workers are needed – pole setters, timers, kitchen help.

A motion was made by Mary and 2nd by Janine to purchase the agility software used by the Kennel club at a cost of \$250. Motion carried.

There was no further business. A motion to adjourn was made by Dave and 2nd by Janine. Meeting adjourned at 9:00 PM.

Board Meeting

The meeting was called to order at 7:10 PM by President Denise Luther.

Old Business: Brian is waiting to hear back from Dean Ambuel, Southwest Arena manager, about availability in September for the trial. Worst case scenario the trials may be dropped for a year to find another date or venue.

New Business: Denise said the "A" Match paperwork is ready to go. It only needs signatures of the Board. Brian will serve as trial secretary, LuAnn Honek as show chairman and Stevie Mathre will judge. The Match will be held February 25 in the Commercial Building of the Red River Fair Grounds. Kitchen help is needed. A minimum of 50 entries is required by AKC. The FM Kennel Club (FMKC) will charge RRNDOC 20% of the profits with RRNDOC keeping the profit from the kitchen. Brian made a motion to hold the "A" Match on February 25; 2nd by Kris. Motion carried. Patti made a motion to purchase the necessary agility software at a cost of \$250; 2nd by Janine. Motion carried. The Club needs to purchase 24" weave poles (2 sets of 6). \$325 has been set aside for this. Wing jumps are also needed. RRNDOC and Denise have enough for a jumpers course. The FMKC will supply the contacts for the standard courses.

Expenses keep going up. The Club needs more money coming in. We may need to cut back on advertising.

Nominations Committee: Kathy agreed to serve on the committee with Lavonne. One other person plus 2 alternates are needed. Emily and Janine can serve another year. The treasurer and secretary are going off the Board. Currently Denise, Kathy and Patti are on the signature card for the bank account.

A motion to adjourn was made by Janine and 2nd by Mary. Meeting adjourned at 7:45 PM.
