Meeting called to order 8:12 pm

Minutes of the last meeting printed in the Paw Prints; corrections to announcements: dates for the Kennel Club Obedience trial in April should be April 14<sup>th</sup> and 15<sup>th</sup>.

Unfinished Business:

Application for our July trials should have been filed in January, we may still have time to have a July Trial if we send in a request for extension; but we must act before the end of February. In order to send in an application we should have member support and committees in place. Dave suggested we wait until next year with the fair and wrestling tournaments hotel reservations may be limited. Brenda questioned having a September trial, need to check shows in the surrounding area that could possibly affect our entries. There were no volunteers for committees, discussion on having a trial this year was tabled until more information was available as to dates available. A reminder that application needs to be made 6 months prior to the trial and if a venue is used that has not been used before it must be approved by AKC.

Treasure Report: We have money in the bank, revenues for January \$4,500.00 and expenses for \$2,163.00.

Trainers Report: Session 2, Monday beginners class is smaller; jump start class is larger. RRN has not been using the Forum for advertising. RRN will schedule a CGC either March or April and again in the fall.

Announcements: NDSU: March 3<sup>rd</sup> St. Pootricks Day (see flyer at RRN training center); there will be another outing to Bethany on University, March 7<sup>th</sup>.

New Business: Suggested if we do not have a trial in July that we have some kind of fund raiser such as a rummage sale.

Agility equipment: we had previously approved the purchase of equipment using the funds from the sale of old equipment; we have aprox. \$380.00 to purchase new regulation weave poles, I am waiting for the final bid and conformation that the weaves are competition grade. The poles we are checking on are \$129.00 for a set of 6 and we will need 2 sets.

Unfinished Business:

Discussed the possibility of a July Trial, we are 30 days passed the time to send in paperwork, but could possibly get an extension from the AKC with an explanation that we are late due to finding a suitable venue.

Before the paperwork will be filed we would like to know how much support from our membership we have. We would like to have volunteers for key positions and a show committee in place. Also discussed having a 2 day compared to a 3 day trial; hiring professional movers to load and unload show truck for setup.

No action taken, tabled for discussion in March.

Discussion on ways to better communicate; Paw Prints and email not effective.

Saturday Agility A Match : will all of the volunteers working the trial and very few offers to bring food at the time, Denise has taken an offer from Marsha S. from the Kennel Club to cook all of the food if we reimburse her for the cost of the food and have 2 people available to work the kitchen.

We will use the proceeds from the sale of food to cover the costs. Workers will receive lunch free. Denise asked that the positions of Treasure and Secretary give the board a list of duties that include filings with different agencies and their due dates; would include Secretary of State and AKC, State and Federal Taxes.

Briefly discussed expenses vs. class income; expenses increasing with income over the last 4 years stable at 22,000 to 23,000. Class income alone will not cover the clubs expenses, fundraising and events are a big part of our net income each year. More class income was generated from the puppy and beginners classes.

Discussed that we should be filing Sales tax on our leashes and collars.
