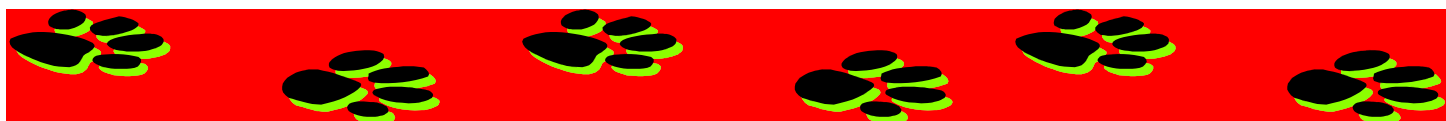

A BIG THANK YOU goes out to all our members who made the Rummage Sale in July a success!

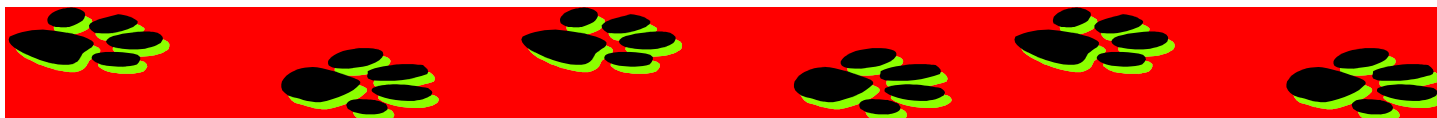
That includes members who loaned the Club their tables and/or who donated their sale items. Also members who set up and worked the Rummage Sale are very much appreciated.
