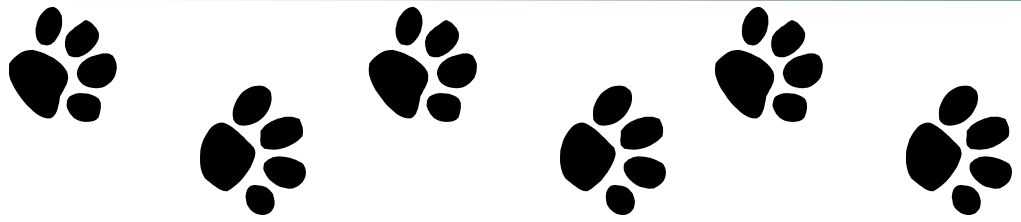

PRESIDENT’S REPORT, November, 2012

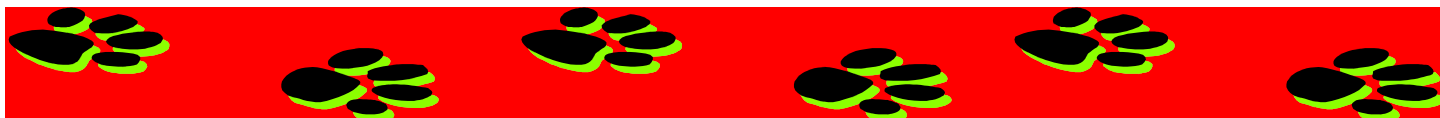
First I would like to welcome the new members that were voted in at the October meeting:

Canine Good Citizenship News

Canine Good Citizen Will Become a Title!

Beginning on January 1, 2013 the Canine Good Citizen® will become an official title that can appear on the title records of dogs registered or listed with the AKC. Dog owners who complete the CGC as a Title process may list the suffix "CGC" after the dog's name. In the past the CGC has been an "award", and could not be listed as a title.

Participants in our Canine Good Citizen test on October 21, 2012 were encouraged to submit their completed CGC Test forms, together with an "Addendum to the CGC Test Registration Form", near or after Jan. 1, 2013 for the CGC Title. The cost for title registration is \$20.

They could also choose to get the CGC Certificate only, for a fee of \$8. In this case, "CGC" would not be listed on the dog's title record.

For those whose dogs have already earned a CGC (after Jan. 1, 2001 to the present) the AKC has provided a "grandfathering" procedure to allow you to apply to have the CGC title listed on your dog's title records. The "Application: Add Canine Good Citizen to your Dog's Title Record (The Grandfathering Form)" may be downloaded from the AKC website, or picked up at RRNDOC. The cost for adding the CGC title to the dog's title record is \$20. Only dogs with an AKC number, a PAL (formerly ILP) number, or an AKC Canine Partners number are eligible. (All dogs, including mixed breeds, can get a registration number in one of these categories). These applications will be processed after January 1, 2013.

Special thanks to our evaluators and helpers who made this event a success. Our CGC Evaluators were Sharon Buethner and Tara Pearson. Janine Barnstuble served as time keeper for "Supervised Separation"; Mary Brinkman and Neela were the "Friendly Dog" team; Jamie Neary, Kathy Lehman, Monica Duhigg and Vicki Gronbach provided the "Crowd" and "Distractions". Thank you!

In addition to the Canine Good Citizen testing, we have administered the S.T.A.R. Puppy Test to puppies completing Puppy Kindergarten and/or Jump Start Obedience classes. So far this year 50 puppies (out of 57 tested) have received the STAR Puppy certification. Our congratulations to all the puppy/handler teams who have passed this milestone in their training. The CGC Evaluators and the instructors of the Puppy Kindergarten classes are responsible for conducting these tests at the end of each session.
