RRNDOC Training Classes in 2013

In 2013 we will be modifying our class schedules to provide better service to our members and other students. We will offer four 8-week sessions from January through August, and two 7-week sessions from September through December.

This revision will allow us to hold our Agility trials (May 16 & 17) and Obedience and Rally trials (Sept. 7 & 8) without losing class time. We will still have generous vacation times: 2 weeks in the summer, 2 weeks over the Christmas/New Year holiday; 1 week (plus) in September prior to our trials; and 5 days for the Thanksgiving weekend. Class fees for the 7-week sessions will remain the same as our current fees; however, we will <u>need to raise the fees in the 8-week session by \$5/class</u>. [See attached Schedule of Classes] Remember that as members you are entitled to a \$5 discount on each class you take!

There is a minor <u>change in the time schedule for Wednesday evening classes</u>. The Advanced Beginners/CGC class will meet at 7:00 PM, and the Novice/Grad Novice class will meet at 8:00 PM.

The Therapy Dog Training class, taught by Ilene Cohen-Pearson and Hollie Halvorson, has completed two full sessions of training. Several dog/handler teams are ready for evaluations for certification.

<u>The Therapy Dog Training class will not be held during the January-February session</u>. It will resume later in 2013. If you are interested in training your dog for therapy work please contact Ilene at <u>therapypetsrrv@gmail.com</u>. I want to take this opportunity to thank all of our instructors and assistants for their dedication to our training program, and the excellent classes that they provide. Thank you!

We invite you all to bring your dogs to classes during the cold winter months. It is a good way to keep the dogs active and stimulated, and to provide some exercise for us as well.
