# Training Director's Report, December 2015

It is customary to pause at the end of a year and reflect on events that have shaped our time together as a club, and the many things that we have been able to accomplish in the past twelve months. As a club we have welcomed new members, conducted six sessions of classes, three Obedience and Rally trials, and five Agility trials. We have watched puppies grow into mature dogs, celebrated the successes of our club members and their dogs at trials, and wept with those who have lost their beloved companions. We have shared our dogs and their skills with residents of many local nursing homes, provided a safe “listener” for children in the Read program, used our dogs as “sales dogs” at Herberger’s Community Days and other events in the community. We have trained and tested dogs in the AKC Canine Good Citizen program—from the S.T.A/R. puppies, to Canine Good Citizens, to the advanced levels of Community Canine and Urban Canine CGC. We have participated in Pet Therapy Training classes, and Clay County 4-H training, and much, much more. It has been a busy and productive year!

**Classes:** Our current session is nearly over. We added a third Puppy Kindergarten class and a third Beginning Obedience class once again. Enrollment has fluctuated, as it does every November-December session, with students juggling dog classes with special year-end activities in local schools and at work.

**Next session : January 4 through February 27, 2016**

**Canine Good Citizen Test:** On November 22, 2015 a CGC Test was held at the training center. Six dogs were entered, four of which passed and became “Canine Good Citizens”!! Congratulations to Tara & Trigger, Krister & Cliff, Jean & Kyoshi and Sharon & Kristi! Thanks to all who helped with the test: Evaluators Sharon Buethner and Hollie Halvorson; Kathy Faeth and Jamie Neary with registration; Rhonda Wensel with supervised separation; and Patti Fritz, Linda Manikowske, Aurelia Kucera and Janine Barnstuble for help with all the exercises. Special thanks to Kaiya and Samus who were our “Friendly Dogs”.

**Retirement:** It has been my great privilege to serve as your Training Director for the past nine years. Last month I tendered my resignation to the Board of Directors, effective December 31, 2015. The Board will be appointing new leaders for our training program who will bring their talents and visions for the future. I hope that you will all give them your support as they begin this adventure. At our Trainers’ Meeting on Saturday, December 12<sup>th</sup> we discussed possible changes that would enhance our training program in the future. We are all looking forward to great things ahead for RRNDOC!
