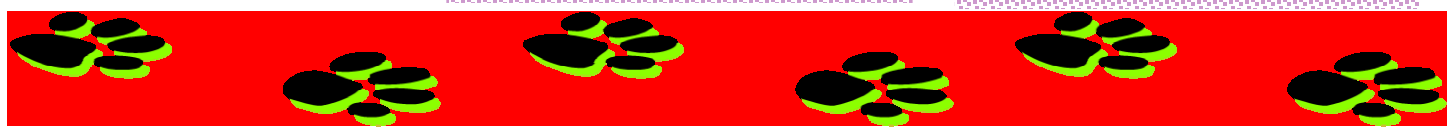

2. Agility Equipment to order: Jump wings – Kathy has been look at. Different colors are available, 18" size. Motion to approve purchase of six sets not to exceed total cost of \$700. Motion by Ann, Second by Dave. Motion carried.
3. Update on Herberger's sales – Kathy Income of \$780, and also got picture frames for silent auctions. Should have another check coming from Herberger's.
4. Parking lot and sidewalk update: Kathy – I just called Protech again today. So now I have talked to both Rod and Dale Mulvaney, and also Dave Burr.
