- Denise Final details for Feb. Agility trial. All done, laptop and software update needed. Entries? Nancy
- Hollie/Sharon thoughts on OB/Rallytrial dates and location? Have to book a year in advance.
   Could do trick dog testing at the same time.
- Ring Gates Need 2 new, should get same as Kennel Club. Motion by Ann to purchase, second by Janine. Motion carried.

#### New Business

- Cyndy can we get the pre-registration sheets sent out to Hollie and myself several days
  prior to the new session start? How are they being sent now? Is there a way we can have a
  Gmail calendar notice/reminder come up before a new session? Rhonda have been
  sending as requested. Make changes very frequently, can email them every time there is a
  change or addition if wanted. Send during workday to Cyndy so she can open the
  worksheet.
- Cyndy send out reminder about increases class costs and punch cards to the trainers?
   (include Lois Eid and Janine). Recommend students should be allowed to use their current punch cards up (at the old rate) and then newly purchased cards will be at the new price.

Kathy – Lawn care. Kathy to get quotes.

Denise – Equipment Fund. \$400-\$500 for new equipment for obedience classes. Instructors should submit list of what is wanted to the board for approval.

FMKC looked at Vanity Buildings. They were way too much money and not enough space. Sports Bubble had mold issues, too much money and inadequate parking. No short term solution found available for rent, purchase only.
