### Training Directors Report

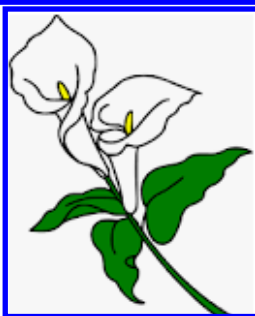
